A. PURPOSE

This policy will apply to all persons who are not members of the SCW Yoga Club.

D. DEFINITIONS

TERM	DEFINITION
Club Member	A Sun City West resident in good standing with the Recreation Centers of Sun City West and a holder of a valid Recreation Card, who has paid the current SCW Yoga Club fee.
Resident Non-Member	A Sun City West resident in good standing with the Recreation Centers of Sun City West who comes to a SCW Yoga Club class or event with the intention of trying out that class or event before deciding to become a member of the Club.
Resident Guest	A Sun City West resident in good standing with the Recreation Centers of Sun City West who is not a member of the SCW Yoga Club but comes to a class or event accompanied by a Club Member.
Non-Resident Guest	A non-resident of Sun City West who cannot become a member of the Club but comes to a class or event accompanied by a Club Member.

E. DESCRIPTION

Only SCW Yoga Club Members may bring a Resident Guest or Non-Resident Guest to a Yoga Club class or workshop (unless the event is designated as a public event). All guests must meet the Club minimum age requirement.

GUEST POLICY

A Resident Non-Member may not bring a guest (Resident Non-Member or Non-Resident Guest) to a Club class unless the host Resident Non-Member first becomes a Club member during the same visit. All guests must meet the Club minimum age requirement.

A Non-Resident Guest MUST be accompanied by a Club Member; Non-Resident Guests may not come unaccompanied. Non-Residents may not participate in Club classes unaccompanied by presenting the Recreation Card of a SCW Resident in lieu of being accompanied by said resident.

F. ENFORCEMENT

Monitors are required to see Club membership and RCSCW Rec Cards before allowing a person to sign into a class. Non-Resident Guests must present a photo ID or, in lieu of a photo ID, have the Club Member host vouch for the age of the Non-Resident Guest.

Resident Guests must present their RCSCW Rec Card or other photo ID before signing into a class. In lieu of a Rec Card or photo ID, the Member host may vouch for the Resident Guest.

G. EXCEPTIONS

As this Club policy is an adjunct to the RCSCW policy, no exceptions will be made. The RCSCW policy will take precedence.
