## MINIMUM AGE REQUIREMENT

### A. PURPOSE

This policy sets a minimum age for participants in Club classes and events.

### B. SCOPE AND APPLICABILITY

All classes and events conducted by the SCW Yoga Club are covered by this policy.

### D. DEFINITIONS

TERM	DEFINITION
Club Member	A Sun City West resident in good standing with the Recreation Centers of Sun City West and a holder of a valid Recreation Card, who has paid the current SCW Yoga Club fee.
Resident Non-Member	A Sun City West resident in good standing with the Recreation Centers of Sun City West who comes to a SCW Yoga Club class or event with the intention of trying out that class or event before deciding to become a member of the Club.
Resident Guest	A Sun City West resident in good standing with the Recreation Centers of Sun City West who is not a member of the SCW Yoga Club but comes to a class or event accompanied by a Club Member.
Non-Resident Guest	A non-resident of Sun City West who cannot become a member of the Club but comes to a class or event accompanied by a Club Member.

### E. DESCRIPTION

The intent of this policy is to ensure that participants in Club classes and events are sufficiently mature to practice yoga with a 55+ age group and is legally able to sign the waiver required of all non-resident guests.

The minimum age of a Club class or workshop participant is 18 years of age at the time of the participation.

### F. ENFORCEMENT

Any person with a Sun City West Resident, Associate, or Tenant card, by virtue of being issued that card, exceeds the minimum age requirement. This statement applies to Club Members, Resident

## MINIMUM AGE REQUIREMENT

Non-Members, and Resident Guests. Enforcement for these categories of participants will be enforced by requiring these persons to present their Sun City West identity card.

Non-resident guests will be required to present photo identification to the Monitor(s) when signing in at the Monitor desk. In lieu of photo identification, the accompanying Club member may personally vouch for the non-resident guest's age.

If the non-resident guest is not 18 years of age or older, that person is not allowed to participate in a Club class or event. There are three reasons for this policy:

1. The underage non-resident guest is not of legal age to sign the liability waiver required of non-resident guests;
2. The accompanying Club member may not be the legal guardian of the underage non-resident guest, so the Club member cannot legally sign for the underage non-resident guest, and;
3. Young non-resident guest (e.g., a grandchild) have been disruptive during classes prior to this policy being put into effect.

Monitors will be expected to support this policy at the Monitor desk.

There will be no exceptions to this policy.
