BYLAW CHANGE: CURRENT STATE

- Current bylaw, Article VI, Section B:
 - Restricts disbursement amounts to \$200.00
 - Amounts over \$200.00 must be approved at a meeting of the club's members
- However, some of our instructors earn more than that amount depending upon the number of class attendees
 - The Treasurer has been writing checks for those earned amounts without getting member approvals
- The current bylaws do not support this practice, which is necessary to make sure we pay our instructors in a timely fashion
- Proposal is to modify our bylaws to reflect our current practice

BYLAW CHANGE: CURRENT STATE

Current bylaw, Article VI, Section B states:

"Section B – Spending Limits

The Club Board may authorize (a) the Treasurer to disburse funds in support of Club activities in amounts not to exceed two-hundred dollars (\$200.00). Expenditures greater than two-hundred dollars (\$200.00) must be approved by a vote of the general membership. Other expenditures of up to twenty-five dollars (\$25.00) or less can be paid by petty cash."

BYLAW CHANGE PROPOSAL

Proposed Article VI, Section B

"Disbursements to Contractors

The Club Board may authorize the Treasurer to periodically disburse funds to contractors equal to the amount earned by each contractor during a specified period of performance. Further, the Club Board may occasionally authorize the Treasurer to disburse one-time disbursements to contractors in an amount determined by the Club Board.

Disbursements Other than to Contractors


The Club Board may authorize the Treasurer to disburse funds in support of Club activities in amounts not to exceed two-hundred dollars (\$200.00). Expenditures greater than two-hundred dollars (\$200.00) must be approved by a vote of the general membership. Other expenditures of up to twenty-five dollars (\$25.00) or less can be paid by petty cash."


ANNUAL MEMBERSHIP DRIVE 1 NOV 2022 – 31 DEC 2022


